2025-26 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Roseville City Elementary held a public hearing on September 25, 2025, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption.

School Facility Conditions and Planned Improvements

General

The District takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the District uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the Maintenance Office.

Maintenance and Repairs:

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. The District annually inspects wheelchair lifts, tests fire extinguishers, inspects and services all playground backboards, replaces bark on playgrounds and landscaping, and services HVAC units.

Overall Summary of School Facilities Repair Status: Good

School Facility Conditions and Planned Improvements

The inspection included a check of possible gas leaks, mechanical systems, interior and exterior doors and windows, interior surface areas, structural damage, electrical, playground equipment, and hazardous materials. In all areas this school passed inspection.

Cleaning Process and Schedule:

The District has adopted cleaning standards for all schools in the District. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget:

The District participates in the State School Deferred Maintenance Program, which provides state matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repairs or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Since 2008-2009 the State has suspended the program due to State Budget Reductions. The District still maintains its own program.

2025-26 School Safety Plan

The Crestmont School Site Council meets annually to review the school's safety needs and make recommendations as necessary. In addition, the Roseville City School District has a Safety Committee, comprised of both certificated and classified employees, that meets annually to conduct reviews of our school facilities. The Roseville City School District has developed a Crisis Response Plan that outlines procedures to be followed in the event of an emergency affecting the school site. The plan outlines procedures for coordinating resources to respond to various emergencies, including natural disasters, environmental health issues, accidents, and intruders. Staff members have been assigned roles and are trained to work efficiently with each other and with other public service officers to ensure the safety of students and staff. The Raptor lockdown process and drill procedures are fully developed. There are monthly fire drills. Soft Lockdown and full Lockdown drills are done throughout the school year.

The Crestmont School Site Council reviews the safety plan annually and makes necessary changes and updates. The Safety Plan was reviewed, updated, and approved by the School Site Council on December 1, 2025, and will be submitted for final approval by the board in February 2026. The Crestmont School staff, students, and parents participate in the PBIS Program. Each month, a specific PBIS skill is highlighted, and students are recognized for their positive behavior and actions during the monthly Flag Salutes.

Crestmont receives district funds to support its academic programs. Our teachers have support materials to provide a more rigorous learning environment, funded with LCFF funds. We used LCFF funds this year to provide online ELA and Math intervention programs, as well as other supplemental materials, for our staff and students. Funds are also used to provide PBIS training for both students and staff. Our K-5 students have access to over 400 Chromebooks, and each classroom has an iPad, Apple TV, and 55-inch flat-screen TVs to support learning. Our parents, through the PTC, support our school with generous donations to fund various projects, including campus beautification, technology, the library, professional development, the arts, and the art docent program.
